

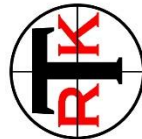
## Meet Our Instructor

**Angela Corey** is a 35 year veteran prosecutor in the State of Florida. Her career began in 1981, when legendary State Attorney Ed Austin hired Angela as an Assistant State Attorney (ASA). For over two decades she served in various prosecution divisions. Towards the end of her tenure as an ASA, Ms. Corey was primarily responsible for the prosecution of all types of homicide cases, handling hundreds of murder investigations and participating in over 55 murder jury trials. She served a two year stint (2007-2008) as a prosecutor in the 7th Judicial Circuit where she was a member of the Homicide Unit. Ms. Corey was elected in 2008 and served as State Attorney of the 4th Judicial Circuit of Florida from January, 2009 until January, 2017.

She has lectured extensively to prosecutors and law enforcement on the local, state, and national level. Her areas of expertise include case preparation, courtroom demeanor and testimony, search and seizure, interviews and interrogations, homicide and the death penalty, ethical issues, victim impact, and opening statements and closing arguments. In the past, she has served as an adjunct professor at Florida State College at Jacksonville and as a lecturer for the National College of District Attorneys and the Florida Prosecuting Attorney's Association.

She has further distinguished her career by achieving board certification in criminal trial law and maintaining that status since 1991. Ms. Corey's numerous achievements and honors include appointment to the Judicial Nominating Commission for the Fourth Judicial Circuit of Florida by Governor Jeb Bush in 2001, where she served a 7 year term. She was also appointed by Governor Rick Scott to the Medical Examiners Commission as the State Attorney representative. Ms. Corey is a Jacksonville, Florida native and loved serving the citizens of the community in which her parents as well as she and her siblings were raised. She received a B.S. in Marketing from Florida State University and her Juris Doctorate from the University of Florida College of Law.

Just as crucial to successful prosecution of offenders as the evidence and probable cause is the case preparation and courtroom presentation.
